Significant Investor Visa

The Significant Investor Visa is a new Australian visa class which provides a pathway to Australian residency for migrants with AUD\$5 million to invest.



Complying investments for the Significant Investor Visa include:

- Commonwealth, State or Territory Government bonds
- Australian Securities and Investment Commission (ASIC) regulated managed funds with a mandate for investing in Australia
- Direct investment into private Australian Companies

The Significant Investment Visa offers applicants greater flexibility than previous visas in terms of investment structure and eligibility requirements. There is no upper age limit and no points testing. The residency requirements have been significantly reduced when compared with other visas.

The temporary visa (188C) requires applicants to invest for at least 4 years in an approved range of complying investment options to then apply for the permanent residency visa (888C).

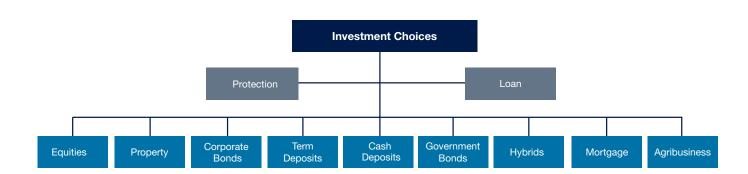

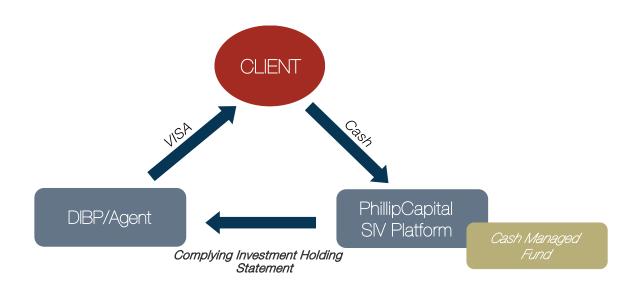
Tax reports and effective tax management
